PROGRAM: "Proving Your Lineage"

SPEAKERS: Donna Spears and Jane Sanzone

This program covers many of the activities and tasks required to determine and to prove lineal bloodline descent from a patriot of the Revolutionary War. It shows a logical approach to connecting one generation to the next with official documents or acceptable substitutes. An actual lineage is presented including the use of vital records, tombstone photos, newspaper obituaries, and the Genealogical Research System (GRS) available to the public at dar.org.

Donna Spears got serious about genealogy in 2009 after she retired from her 20-year career as a technical writer. In 2013 Donna and her husband, Joe, visited a small, abandoned family graveyard in South Dallas where they found the history resources in Tralee. Jane became 1866 gravestone of Thomas M. Smith -Donna's great, great, great grandfather. The journey that followed included their search of old Dallas County deeds, an uncooperative surrounding land owner, the Texas Historical Commission, an attorney, a lawsuit, a retracement surveyor, ground penetrating radar, and more as they fought to keep the surrounding land owner from building a parking lot on the ancestors' cemetery. When the Court asked Donna to prove she was a descendant of the family interred in the cemetery, she did just that. The matriarch of the pioneer family who came to Dallas in 1851 was Polly Medearis Smith, the youngest child of Major John Medearis, who served in the US Army for seven years and fought in the War of the Revolution with his third cousin, George Washington. After the lawsuit was won and the

historic cemetery was thoroughly recorded in the Dallas County records, Donna had the lineage data needed to join the National Society Daughters of the American Revolution as a descendant of John Medearis. There are numerous DAR members descended from his two sons and older daughter but none from the younger daughter, Polly, until Donna proved her. Donna, a graduate of Denton High School and TWU, serves as Recording Secretary and Chair of the Lineage Research Committee of the Benjamin Lyon chapter NSDAR.

Like the majority of her ancestors, Jane Sanzone is a native New Englander with deep roots in New Hampshire and Massachusetts. She moved to Denton in 1987 to pursue a graduate degree in art history and to get away from the cold New England winters! Jane's interest in family history started at an early age due the knowledge that her grandmother had immigrated to the U.S. from Ireland in the 1920s. On her first trip to Ireland in 1998, she visited her grandmother's townland in County Kerry and spent time searching through local serious about genealogy in 2011 when she decided to complete a certificate program in genealogical research through Boston University. In 2014 she joined the New England Historic Genealogy Society on a research tour to Dublin, Ireland, to continue research into her Irish ancestors. Upon returning home, she decided to further explore her New England ancestry and discovered a goldmine of colonial and revolutionary war era ancestors. Jane joined the Daughters of the American Revolution (DAR) in 2015. Since joining DAR, Jane has completed the Genealogy Education Program courses I-III as well as the course DNA and the DAR. She has served as the Benjamin Lyon Chapter's Registrar since 2017.


