APRIL 2025 MEETING MINUTES

Denton County Genealogical Society, Inc. April 10, 2025 minutes

President Bob Lane called the meeting to order at 7:00 p.m. and led the members in the Pledge of Allegiance. There were 24 members present with four on Zoom. There were three guests: Marty Medrano, Jodi and Knox McRae. With our speaker, we had 31 in attendance.

Reports by Board Members

Membership: Marian Carroll, chair, introduced our visitors.

Secretary: Minutes taken by Eileen O'Neill at the March 13, 2025 meeting were published in the newsletter. There were no objections to approving the minutes as published.

Treasurer: The report by Linda Lane is in the newsletter. The financial report was approved as presented and will be filed for audit.

Social/Hospitality: Joan Anderson was ill so Marian Carroll set up our snacks. Monica Wenthold supplied the delicious blueberry bread.

Librarian: Laura Douglas mentioned that Connections, the genealogy discussion group, is meeting on April 25 from 11:00 a.m. until noon at Emily Fowler Library. Registration opened April 11th. There are stacks of journals at the back of the meeting room, free to anyone who would like them.

Newsletter: Nancy Gilbride Casey was not here tonight so Bob Lane gave her report. For the May "Ancestor Question of the Month" we will repeat last year's theme of "Your Favorite Ancestor Photograph" since it was such a success. So, dig out a favorite picture and send it to the newsletter editor. Instructions will go out in an email in the next few days.

Scholarship Committee: Bob gave Nancy's report. We will open the Diana Pearson White Continuing Genealogical Education Scholarship applications at the May meeting. We would LOVE to give someone up to \$200 to attend a genealogical workshop, class, or other event during Fall 2025 or Spring 2026. Preference will be given to first-time attendees at a paid event, but all are welcome to apply. Applications will be due in September.

There was no new business.

Announcements

- President Bob Lane announced the appointment of a new webmaster to take the place of Chris Strauss. We appreciate Charlene Case for volunteering and thank Chris for his service to DCGS.
- ♦ There will be a discussion of "How to Start Writing Your Ancestors' Memories," with Emily Richardson on April 18 at Emily Fowler. This is part 2 of the discussion; please register to attend.
- ♦ DCGS will elect new officers at the May meeting. The nominating committee has announced nominations: President Eileen O'Neill; Treasurer Linda Lane,

Librarian – Laura Douglas.

Marian Carroll had been treasurer for a year when she switched to membership chair, and Linda took over as treasurer. Since Eileen is currently secretary, Bob Lane has agreed to take over the second year of her two-year term. If anyone would like to be considered for one of these offices, either now or in the future, please contact Bob Lane, Beth Leggieri, or Eileen O'Neill. President Lane stated that it is important to have a change in leadership to bring fresh perspectives and ideas to our society.

- President Lane mentioned that TIGR, the Texas Institute of Genealogical Research, will hold a week-long virtual conference from June 16-20. There will be nationally known instructors for these courses. Registration is open.
- ♦ Stacie Briggs announced her April family history class, "Resolving Conflicting Evidence" on April 26 from 10 a.m. to 11:30 a.m., at the Family History Center.

Programming: Stacie Briggs, vice president for programs, announced that Saturday, April 12, there will be a DCGS member field trip to the Denton County Historical Park to have a guided tour through the historical buildings. Stacie also asked that members fill out the end-of-year survey asking for ideas about future programs that members would like to see. Next month, the program will again be our member discoveries. This is especially fun if a discovery is based on one of our speakers. Presentations should be limited to 5-7 minutes. Email Stacie by May 6 to volunteer.

Stacie introduced our speaker, Megan Joblin, Denton County Historical Park manager; she spoke on "The Keepers of Denton County History."

President Lane asked for questions or comments and thanked Megan for her presentation.

President Lane reminded the membership that our next meeting is May 8.

President Lane's last word is from George W. Bush: "So, I'm lying on the couch and Laura walks in and I say, 'Free at last,' and she says, 'You're free all right, you're free to do the dishes.' MY FAVORITE ANCESTOR PHOTO

This month we feature some of our members' favorite photographs!





Donna Spears submitted these photos of Francis Wildey and Alice Baldwin, Myers her greatgrandparents. "In August 2024 our Find a Grave account received a message from a stranger. He wrote that his hobby was to shop in antique stores for photos which had names on the back. Then he researched the people to find living descendants to whom he could give the photos. That's how I received very clear photos of my maternal great-grandparents. The very generous stranger declined reimbursement for the photos and the postage to mail them to me. What an amazing, kind hobby."

Ginny Richards writes, "This is a photo of my great-grandfather (at the left anvil), Harvey Franklin Barger, his brother (at the right anvil), Newton Allen Barger, and two other unidentified men in the Barger Bros. Blacksmith shop in Cedar Vale, Kansas. I believe this photo was taken in the 1910s.

One interesting fact about Cedar Vale is the town (founded in 1869) was laid out on the diagonal, rather than aligned with the N-S compass points, giving an unobstructed view of the Caney River and Cedar Creek Valleys."

John Windsor writes, "This is a photo taken in 1946, in Wilmington, Delaware, showing four generations of Windsor men. I am the one in the blankets, held by my father, Clayton C. Windsor. In the center is Rev. Lester E. Windsor, and to the right is George W. Windsor who passed away four months later. This is the only picture every taken of all four generations. "

Sandra Robertson writes, "The woman on the left is my maternal grandmother, Nancy Jane Stevens West. The woman on the right is my paternal grandmother, Minnie Moore Dockrey. Nancy died four months before I was born. Minnie died when I was two years old. I miss never having known grandmothers. On a personal note about Nancy's picture-my mother told me that she was too old to have her picture made with hair down, but grandfather loved her long hair and requested it be down in the picture."







"The photo shows my father, Charles S. Robertson, Sr., at the piano," writes *Charles Robertson*. "His friend, Van Valentine, is playing violin. They were part of a small musical group which Van organized and directed, and which had a Sunday afternoon program on the local radio station for a few years. The studio was a room added to the Valentine's residence. It had a pipe organ, piano, and various kinds of recording equipment."

JOBLIN SPOTLIGHTS COUNTY'S COURTHOUSE ON THE SQUARE AND HISTORICAL PARK

In her presentation, "The Keepers of Denton County History," Megan Joblin, MA, provided valuable and historical information about the Denton County Courthouse on the Square, as well as the Historical Park located nearby. Ms. Joblin is the Historical Park Manager for the Denton County Office of History & Culture (OHC).

The current Courthouse on the Square is the third county court building built in Denton. The first courthouse was built on the north side of the square in 1857 but burned down in 1875. In 1877, a yellow brick building was built in the center of the square but was demolished after it was struck by lightning around 1895. In 1896, the cornerstones of the current building were laid. The courthouse was designed by W.C. Dodson and used locally quarried limestone brought to the site by wagon. The tools used by the masons to build the structure are displayed in the Courthouse-on-the-Square Museum. Unfortunately, the courthouse is currently closed for renovations and will hopefully open in Fall 2025. As stated by Ms. Joblin, "Many efforts are being made to bring the interior of the building back to its original glory."

The Denton County Historical Park (located near the courthouse) is the home to five historical homes. The Bayless-Selby House (previous owners included the Bayless and the Selby families), was purchased by the City of Denton. The home was moved to the Historical Park in 1998 and opened as the Bayless-Selby House Museum in September 2001. The Denton County African American Museum—once a home in the displaced Quakertown Community—was moved to the Historical Park in 2004. The two museums are currently open Tuesday-Saturday, 10 a.m. – 2 p.m. (April-October).

The Historical Park has a structure called the Welcome Center (previously a servants' quarters brought from Lewisville), but Ms. Joblin noted that the structure serves more accurately as a small office space. The Taylor Cabin, a log house originally built around 1868, and the Woods House, another home from Quakertown Community, are also located in the Historical Park. Coming soon: a General Store from Stoney Town (now called Ponder) will be added to the Historical Park.
